Survey Method

In January 2011, the South Dakota Criminal Statistics Analysis Center (SAC) surveyed sheriff offices in the State. An unique electronic survey questionnaire link accompanied by instructions was sent to all sheriff offices via email.

This was the 14th time the SAC compiled statewide management data pertaining to South Dakota sheriff offices. The results of this survey are intended to provide sheriffs with a valid means of comparing expenditures and resources of offices across the State. In addition, the results should provide the sheriffs with a substantial basis from which to justify future managerial decisions.

Currently, there are 66 sheriff offices in South Dakota (this figure does not include tribal agencies). Forty-five offices returned surveys yielding a total response rate of 68%.

The survey instrument is a self-report completed by the sheriff or office staff. All questions were designed to be objective; however, some questions may have been subject to different interpretations. Thus, this report can only reflect summary results that are as valid and accurate as the data provided by each office.

It should also be noted that salary data throughout this report are approximations. Due to the number of personnel at any given rank and the diverse salaries relative to each officer, such approximations were necessary in order to perform overall summary calculations.

General

The responding offices are arranged in ascending order by county population. This method of presentation allows the offices to make comparisons with other counties of similar size. Population estimates for 2010 are provided by the F.B.I. These estimates are derived using the most current data available from The U.S. Census Bureau. The counties are broken down by population as follows:

Twelve sheriff offices are the only entity housed within their building while 33 sheriff offices are housed with other offices, agencies, etc.

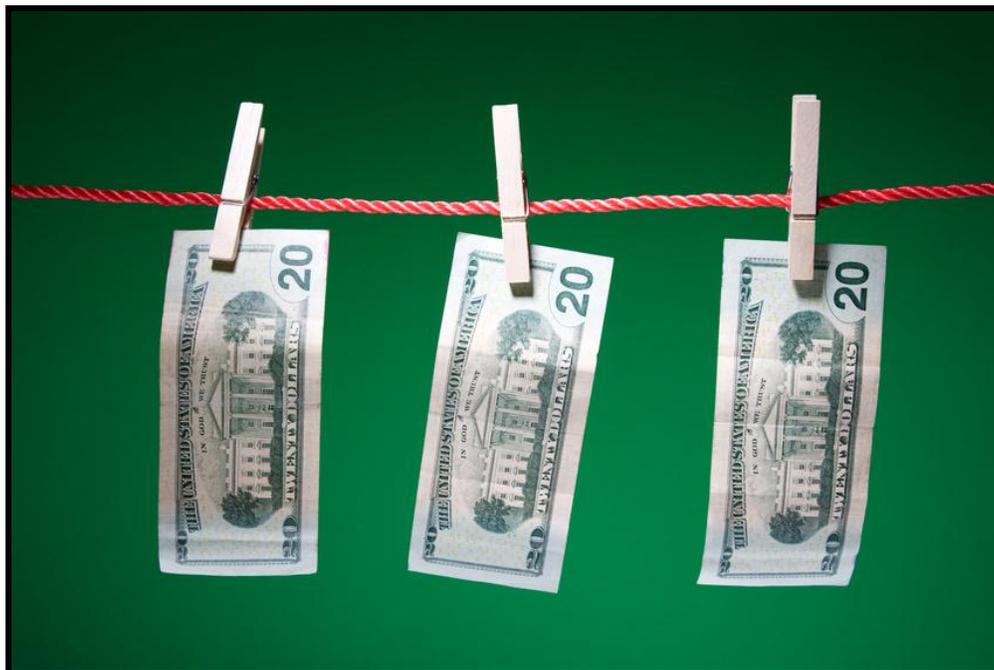
Of the 33 offices that are housed with others, 5 sheriff offices share personnel with the other entities housed within their building; 28 do not share personnel.

When asked if their office shares equipment with other entities housed within their building, 23 sheriff offices said yes; 22 do not share equipment.

Budget

The survey asked to specify the budgeted sources of income for 2010. The total income available to the responding agencies ranged from a low of \$76,050 per year to a high of \$26,553,971 per year. *Note: This does not include the Jail Budget (\$34,919,616) listed on page 27 for offices that have a completely distinct budget for their jails.*

Per Capita Cost of Law Enforcement

The 45 reporting sheriff offices serve counties ranging in size from 1,299 to 185,686 people. The combined total population of these jurisdictions is 697,172. By dividing the budget total expenses for all responding agencies, \$54,961,527, by the combined population of 697,172, a per capita cost of county law enforcement services of \$78.83 is obtained. The per capita cost ranged from a low of \$35.56 for the population grouping 10,000 to 19,999 to a high of \$136.40 for the population grouping of under 2,000.

Officer Salaries

The Sheriff's salary schedule is set by SDCL 7-12-15. The statute states: "The board of county commissioners shall establish, by resolution, the salary payable to the sheriff. The salary payable may not be less than the following schedule based upon the most recent decennial federal census of population of counties. The board of county commissioners may not decrease the salary of the sheriff during consecutive terms of office of the sheriff. Any sheriff having responsibility for managing a full-time jail shall receive an additional ten percent added to the base salary listed in this section."

The Sheriffs were asked how the wages/salaries of the sworn officers (other than themselves) in their offices are determined. Thirty-two (71%) of the responding offices indicated the salaries were established at the discretion of County Commissioners. Eleven (24%) of the offices reported that a salary schedule or policy is in effect. One (2%) office reported that salaries are determined by Union Contract. One (2%) office reported that salaries are determined by Law Enforcement Board.

Sixty-two (18%) of the full-time, sworn county law enforcement officers in South Dakota are from 35-39 years old. For the 354 officers reported by offices, the gender breakdown is: 328 (93%) male, 21 (6%) female, and 5 (1%) not reported.

Education

Since October 1, 1971, the Law Enforcement Standard and Training Commission requires a high school diploma, or the equivalent (GED), before any officer may be enrolled in the 12 Week Basic Certification Training Session. This course is necessary for certification as a law enforcement officer. Individual offices may have further minimum requirements for education to get hired or to achieve specific ranks within their particular agency.

Forty-three offices (96%) of those surveyed offer a retirement program to their sworn officers. Forty-two offices (93%) furnish basic equipment to their officers and thirty-seven offices (82%) furnish uniforms while eighteen offices (40%) provide a uniform cash allowance.

Personnel Benefits

Education

Nine (20%) of the 45 responding offices provide tuition assistance for employees, 36 (80%) offices do not. Two of the offices that do not provide tuition assistance are considering instituting a program that would provide tuition assistance to their employees.

Insurance

South Dakota sheriff offices provide a wide variety of insurance plans for officers and their families. Many offices pay for these plans in full or in part, thereby reducing the financial burden on each officer.

Forty-five offices (100%) pay partial or full health insurance premiums for their officers. The following table illustrates the types of insurance available to the officer and his/her family and the level of premium paid by the office:

Vacation

Sick Leave

Forty offices (89%) have a sick leave policy; five (11%) have no sick leave policy. The amount of sick leave hours that can be earned varies from 25 to 480 hours per year. The most common policy, 16 offices, earn up to 96 hours per year.

Twenty-seven offices (60%) pay a portion of unused sick time to employees when they retire. The amount that is paid back varies widely, from a range of 0 to 1,440 hours or a range of 0% to 100% of the sick leave balance.

One office pays a wellness benefit for unused sick time each year.

Forty-three offices (96%) pay and/or compensate their line officers for overtime. Nineteen offices (42%) pay and/or compensate their supervisory officers for overtime. Twenty-four offices (53%) pay overtime, 21 offices (47%) pay at the rate of time and one-half, one (2%) pays straight time, and two offices (4%) did not specify.

Second Job

Forty-four offices (98%) permit their officers to work a second job; one office (2%) does not. The following table demonstrates the limitations, if any, placed on sworn officers who routinely work second jobs (an office may list more than one type of limitation):

Vehicles

All forty-five offices reported a combined total of 400 vehicles. There are video cameras in 242 (61%) of these vehicles. SUVs (44%) and cars (47%) make up the majority of the vehicles. Pickups account for 6% of the total vehicles.

Twenty of the 45 responding offices (44%) replace vehicles per commissioner's discretion. Six offices (13%) replace vehicles based on both age and mileage; 10 offices (22%) replace vehicles based on mileage; and one office (2%) replace vehicles based on age. Five offices (11%) indicated that they had no schedule or policy for replacing vehicles.

At the end of this publication are tables that list the equipment owned by each office in their respective population grouping.

Weapons

Twenty-one offices (47%) report that the duty weapon can be used only on duty. Of the 24 offices (53%) that allow a backup weapon to be carried, three offices allow any caliber. The other 18 offices allow calibers such as 9 mm, .357 .38, .380, .40, and .45.

Shotguns

Forty-four offices (98%) report issuing a total of 258 shotguns. Thirty-two counties (71%) carry both shotguns and rifles in their vehicles, six (13%) carry shotguns, three (7%) carry rifles, three (7%) did not specify. One office (2%) does not report having any shotguns. Three offices that have shotguns changed from carrying a shotgun to carrying a patrol rifle.

Less-Lethal Rounds

Six (13%) report utilizing less-lethal rounds consisting of bean bags, rubber pellets, gas, pepper balls, sage rounds, and distraction poppers.

Tasers and Stun Guns

Twenty-seven offices (60%) report owning a total of 164 tasers. No offices reported owning stun guns.

Community Policing

Thirty-four (76%) of the responding offices participate in a child fingerprinting program. Twenty offices (44%) participate in Bicycle Helmet/Safety. Twenty-one (47%) of the responding offices participate in Speakers on Crime Prevention. The following table shows how many offices participate in the following programs:

Contract Law Enforcement

A section of the survey was devoted to sheriff offices providing law enforcement services to municipalities in their jurisdictions. *Forty-four (98%) of the 45 responding sheriff offices reported a total of 235 municipalities located within their counties. Thirty of these offices have a contract to provide law enforcement services to at least one of the municipalities in their county. Six sheriffs, including Aurora County, Campbell County, Jerauld County, Marshall County, McCook County, and Ziebach County indicated that their offices provide contract law enforcement services for all of the incorporated areas within their jurisdictions.

Thirteen offices are paid based on an annual rate, with a range of \$5,000 to \$281,400. Eight offices are paid based on an hourly rate with a range of \$21 to \$34 an hour. Three offices are paid based on various per city rates ranging from \$1,800 to \$131,728. Three offices reported “other” for the method of payment; one was a monthly rate of \$1,000 per month, one is quarterly, and the other was based on a percent of expenses. One office is based on a per capita rate of \$80.90. Two offices did not indicate method of payment. No office is paid based on a daily rate.

All of the 30 offices provide year-round contract services. The number of hours per month spent by these offices providing services to municipalities range from 20 hours to round-the-clock.

Three offices (7%) have a year round contract to provide law enforcement services for federal agencies. Two offices patrol federally owned property and did not report the hours per month for law enforcement services. The office that provides jail administration reports the hours per month for law enforcement services is 24/7.

* Buffalo SO reports no municipalities (incorporated areas) in their county.

Cities Not Under Contract

Thirty-seven offices (82%) report that a collective total of 128 cities of less than 1,000 in population are not under contract with the sheriff's office. Several of those cities not under contract with the sheriff's office have on-call protection, police departments, and/or routine patrol.

Warrants

Thirty-seven offices served 31,646 warrants and received 38,583 warrants. As of January 1, 2011, 33 offices reported a total of 40,159 warrants pending from prior years.

Thirty-five offices served 1,800 out-of-county warrants and 34 offices received 2,933 out-of-county warrants. Fifteen offices reported spending a total of \$143,246 in extradition costs, averaging \$9,550 per office.

Many offices have full-time and part-time dedicated positions to the processing of warrants. Of the responding offices, 32 offices reported 116 full-time officers and five offices have 14 part-time officers. Nine offices have 24 full-time civilians and six offices have six part-time civilians.

Civil Process

Forty sheriff offices served a combined total of 68,151 civil papers in 2010. Thirty-eight offices collected \$1,097,270 in civil fees that were turned over to the County Treasurers. Thirty-one offices reported collection of \$223,160 for mileage fees that were related to the civil process. Four counties (Potter, Hand, Pennington, and Turner) have constables to aid in the civil process.

Some counties do not record their civil process activities. Therefore, the statistics presented here should not be viewed as comprehensive totals for statewide civil process procedures. These totals are lower than the actual statewide totals would be.

Most of the sheriff offices keep track of the degree of satisfaction for executions served based on the amount of fees returned to the County Treasurer. Thirty-six offices returned 7,242 executions in 2010, with 33 reporting a total dollar value of \$2,126,994. Thirty-one offices reported 585 executions were returned fully satisfied. Twenty-nine offices reported 525 executions were returned partially satisfied. Thirty-five offices reported 3,766 executions were returned unsatisfied. Twenty-four offices reported 530 executions were still pending. Twenty offices reported 432 executions carried over from previous years. Eleven offices reported 1,127 executions that received no action (i.e., aid to garnishment, etc.).

These 1,127 were included in the total executions sum of 7,242. There were 277 executions from one county included in the total that could not be broken down into individual categories.

The degree of satisfaction should not be seen as a reflection on the quality of work done by the specific sheriff offices. Many factors are involved in whether an execution is satisfied or not, and these factors will vary among jurisdictions. One such factor includes executions that receive no action because they are in aid of garnishment.

Twenty-five offices reported collecting a total of \$683,851 in delinquent taxes. Property taxes collected for the local county total \$75,783. Mobile home taxes collected for the local county total \$297,143. Sales and unemployment taxes collected for the state totaled \$265,753. Nine counties were unable to break down \$45,172 in delinquent taxes. This amount is included in the \$683,851 total delinquent taxes sum.

Sheriff Dogs (K-9)



Six sheriff offices (13%) reported owning a total of six dogs. Five offices reported that the dogs are primarily used for drug detection work. One office did not specify how their K-9 is primarily used. None of the dogs have been used for search and rescue.

Thirty-four offices (76%) have access to a K-9 from another agency. Four offices (9%) are planning to purchase a dog within the next two years.

Computers

The following table breaks down the desktop computers collectively owned by the 45 responding sheriff offices.

Turnover

Twenty-four offices (53%) had no full-time officers leave their office during 2010. Sixteen offices had a total of 32 officers resign; four offices had a total of six officers retire; and seven offices had a total of eight officers dismissed. No offices reported any officer deaths.

County Jails

Jail Facilities Out-Of-County

Twenty-Five (56%) of the counties responding to the survey have a formal contract with another jurisdiction to house prisoners. Twenty counties did not report a formal contract. Four of these counties also operate their own jail facility.

The following statistics vary in that some facilities did not track some of the specific statistics. Twenty-four did not report total fees, Twenty-three did not report total prisoners, and twenty-two did not track their mileage.

There were a total of 2,484 prisoners reported housed in another county's jail facility. Of these total prisoners, 2,232 were reported by counties without jail facilities. The number of prisoners taken to another county's jail facility ranged from two prisoners in one county to 1,179 prisoners in another county.

The responding sheriff offices traveled over 871,070 miles transporting prisoners. Of these total miles, 117,436 were reported by counties without jail facilities. The jail fee paid for each prisoner per day ranged from \$45 to \$80. Eight counties paid \$65 per prisoner per day, and six counties paid \$55 per prisoner per day. The total reported dollar amount spent by responding offices in 2010 for jail fees to other jurisdictions was \$1,746,858. Of this total, \$1,340,974 was reported by counties without jail facilities.

Jail Facilities In-County

Twenty-one (47%) of the counties responding to the survey operate a jail facility. Nine (18%) of these facilities are classified as Regional Jail Centers; that is, they house prisoners from other jurisdictions as well as from their own. Another eight (18%) have Full Jail Facilities and are able to house their own prisoners for extended periods of time (longer than 72 hours). Three (7%) of the counties have Limited Holding Facilities which are limited to housing prisoners for less than 72 hours. After 72 hours of being incarcerated, the prisoners in the Limited Holding Facilities must be transported to a Regional Jail Center in a neighboring jurisdiction.

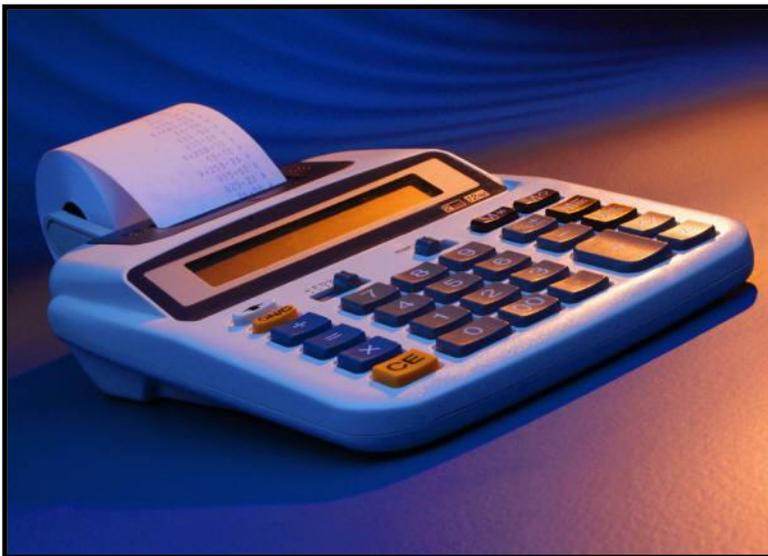
Of the 21 counties that have a jail facility, 10 (48%) of them have a contract with the U.S. Marshal's Office to board federal prisoners.



Jail Budget

Nineteen offices reported a combined jail budget total of \$37,088,062. Not all offices reported all budgeted items. The jail budgets are further analyzed for each county in detailed tables located in the back of this section. The authorized salary range (low to high) for the correctional officers is \$24,000 to \$72,277. The combined jail budget by category for reporting offices is as follows:

When reviewing the jail budget data, it is important to realize that some offices have completely distinct budgets for their jails, separate from their office budget. Other counties cannot separate jail costs from their total budget. In these counties, it is difficult to distinguish the expenses incurred for jail personnel from the office personnel

costs, and the jail operations expenses from the office expenses, etc. Budget comparisons among these counties are difficult.

Jail Personnel

The responding 19 counties report a total of 620 employees involved in the operation of the jail facilities. Eighty-two percent (511) of these are full-time employees, with 18% (109) working part-time. The jail personnel are involved in direct custody functions, clerical/maintenance activities, and/or the administration of the facilities. Seventy-six percent (472) of these employees are involved in direct custody functions, with titles such as correctional officer, guard, jailer, etc.

It should be noted that the meaning of the term “jail personnel” will vary among offices. Of the 19 responding offices, 10 counties report that jail personnel have varied responsibilities within the offices; such as deputies, dispatchers, and secretaries in combination with their duties as correctional officers. These split responsibilities should be noted when examining the detailed tables in the back of this section for the specific offices.

Collectively, the number of correctional officers that have shared duties breaks down as follows:

Jail Fees

Responding agencies report that the daily jail fee charged to other jurisdictions for boarding prisoners averages \$65.18 per day. The range was \$45 to \$223. The highest fees paid were for juvenile prisoner days. The collective total amount of jail fees received from other jurisdictions in 2010 was \$20,392,460. The total amount of county work release monies collected was \$6,187,200.

Convicted/Unconvicted Inmates

County jails often serve a dual function as detention facilities for the unconvicted and as confinement facilities for persons convicted of offenses. The following table analyzes this information collectively:

Jail Age

The average age of a jail facility is 37 years. The range was from 1-year-old to 103-years-old.

The remaining information collected for the jails is presented in tables following the "Jail Definitions". The counties are arranged alphabetically within the following categories: 1) Regional Jail Centers; 2) Full Jail Facilities; 3) Limited Holding Facilities; and 4) Counties Without Jail Facilities. Definitions are provided for clarification.

Jail Definitions

Regional Jail Center – jail facility which houses prisoners from at least one other jurisdiction in addition to the county’s own prisoners.

Full Jail Facility – able to house county’s own prisoners for extended periods of time (longer than 72 hours).

Limited Holding Facility – limited to holding prisoners for less than 72 hours. Any prisoner who must be incarcerated for more than 72 hours must be transported from a limited holding facility to a regional jail center.

Total Jail Personnel – includes both full and part-time employees involved in jail operations. May include personnel with other responsibilities in the office.

Receive Prisoners From – the counties a regional jail center will receive prisoners from.

Total Prisoner Days – the sum total of days that each prisoner spent in jail. For example, three prisoners for four days equals 12 prisoner days.

Out-Of-County Prisoner Days – number of prisoner days when inmates were held for other jurisdictions, such as neighboring counties and federal agencies.

Daily Fee Charged – price charged per day to other jurisdictions for boarding their prisoners.

Prisoners Received – number of prisoners received by the facility in the year 2010.

Prisoners Taken To – jurisdiction where counties with a limited holding facility or no jail facility take their prisoners.

Total Prisoners Transported – number of prisoners the county had to transport to another jail facility in the year 2010.

Mileage Transporting Prisoners – number of miles traveled by the office transporting prisoners to another facility in the year 2010.

Daily Fee Paid – price paid per day to another jurisdiction for boarding of prisoners.

Total Jail Fees Paid – total dollar amount spent by the office in the year 2010 in jail fees to other jurisdictions.

Total Jail Fees Received – total dollar amount received by regional jail centers from other counties for boarding their prisoners.

Work Release Monies Received – dollar amount of county work release monies collected by the office in the year 2010.

Hughes County Jail and Juvenile Justice Center located in Pierre, SD. Construction was completed in early 2010. The jail has 144 beds and the cells are double bunked in the main housing area.

The facility includes a 24-bed work release area. It is comprised of dorm space divided into two separate areas for males and females. There are 18 male beds and six female beds. A 16-bed juvenile detention area, which is divided into four pods, is also part of the facility.

Training

Deputy Advanced Training

Offices were asked how many hours of advanced training are received per deputy, per year on average. Deputies received advanced training in 22 offices (49%). The number of hours ranged from a low of ten to a high of 80 hours. Fourteen offices (31%) reported 20 hours of advanced training per deputy, per year. Eight offices (18%) reported 40 hours.

Eight offices (18%) require a certain number of advanced training hours per year for deputies. The number of hours per year required ranged from a low of 10 hours to a high of 92 hours per year.

Correctional Officer Certification

Twenty-eight offices (62%) are in favor of a requirement that correctional officers have to be certified.

Jailer Advanced Training

Offices were asked how many hours of advanced training are received per jailer, per year on average. Jailers received advanced training in eight offices (18%). The number of hours ranged from a low of five hours to a high of 40 hours. Two offices (4%) reported 10 hours of advanced training per jailer, per year. Nineteen offices (42%) require a certain number of advanced training hours per year for jailers. Five (11%) offices require 40 hours of advanced training per year for jailers.



Deputy Firearms Qualification

Thirty-six offices (80%) require deputies to qualify with firearms. Yearly qualification is required by 28 offices (62%). Eight offices (18%) require bi-annual qualification and no office requires quarterly qualification.

Policies

Pursuit Driving

Offices were asked if they had a written policy on pursuit driving. Thirty-nine offices (87%) do have a written policy. Offices that have a written policy on pursuit driving were asked to check the option that best fit their policy. The breakdown is as follows:

- 18 Restricted criteria based on speed/offence, etc.
- 6 Decision left to officer's discretion.
- 13 Decision left to supervisor's discretion.
- 2 All vehicle pursuits are discouraged.

Use of Deadly Force

Forty-one offices (91%) do have a written policy on use of deadly force.

Violations of Protection/Stalking Orders

Offices were asked if they had a written policy regarding arrest for violations of protection/stalking orders. Thirty-seven offices (82%) do have a written policy. Offices that have a written policy on violations of protection/stalking orders were asked to check the option below that best fit their policy. The breakdown is as follows:

- 30 Mandatory arrest policy
- 6 Pro-arrest policy

Protective Body Armor

Fifteen offices (33%) have a written policy requiring sworn officers to wear protective body armor while 30 offices (67%) do not have a policy. All fifteen offices that have a written policy responded that their office provides body armor.
